- Indications, considerations, and risks of chemical neurolysis for cancer pain





ASRA Pain Medicine Guidelines for Assignment of Space: The priority points system has been established to fairly assign space at all ASRA Pain Medicine meetings and events. Point totals are based on the 12 months preceding June 24, 2025, the date booking forms must be received to benefit from the point system.

- All requests for space must be submitted by the sponsoring company via the official booking form.
- Earliest submitted forms will have preference if companies reach equal point totals. If forms arrive on the exact same date, ASRA Pain Medicine reserves the right to assign space based on a company's previous support of ASRA Pain Medicine.

Exhibitor Personnel Registration

 Companies paying the exhibit fee will receive a pre-determined number of exhibitor badges, depending on the size of booth space purchased, as detailed below.


